

No. MWA- 03.2011/CR-19/LAB-7.- The following draft of a notification which is proposed to be issued by the Government of Maharashtra, under section 27 of the Minimum Wages Act, 1948 (XI of 1948), in its application to the State of Maharashtra, with a view to add “**Employment in Domestic Work**”, in Part-I of the Schedule appended to the said Act is hereby published as required by section 27 of the said Act, for the information of all the persons likely to be affected thereby; and notice is hereby given that the said draft will be taken into consideration by the Government of Maharashtra after the expiry of three months from the date of

publication of this notification in the Maharashtra Government Gazette.



### DRAFT NOTIFICATION

No. MWA- 03.2011/CR-19/LAB-7.- In exercise of the powers conferred by section 27 of the Minimum Wages Act, 1948 (XI of 1948), in its application to the State of Maharashtra, (hereinafter referred to as "the said Act"), the Government of Maharashtra, after giving notice of its intention so to do, as required by the said section, hereby adds to Part I of the Schedule to the said Act, the following employment in respect of which it is of the opinion that the minimum wages should be fixed under the said Act, namely :-
